

Oregon Adaptive Sports Heroes Weekend

Oregon Adaptive Sports, based in Bend, OR, provides a year-round program of sports and activities for people with disabilities. COVID changed things for a while, but in early 2023 they plan to once again run their "Heroes Weekend". They invite disabled veterans to enjoy a weekend of free skiing and lessons, including their specialized adaptive ski equipment.



You can ride the ski lift to the top of Mt. Bachelor with a guide, and ski down on a sit-ski with as much or as little assistance as you wish. You can choose to just hang on for the ride as a guide takes you down the slope, handle the whole thing yourself with outrigger hand skis, or anything in between. Whatever your challenges are, the OAS guides help you in the way you need.

I (ambulatory with MS) was very frightened of trying downhill ski lessons and they could not have been more patient and encouraging for me on the beginners' "bunny slope". The following year I opted for their Nordic/cross-country option instead though!

Heroes Weekend includes your hotel stay and most meals, and is a great way to meet other veterans. OAS have told me that for the 2023 weekend, they are running a smaller program. They want to focus on veterans who are new to OAS and have not participated in Heroes Weekend before. Particularly those who will use the adaptive ski equipment. Your family members are also included and I believe they get discounted equipment rentals and lift tickets.

More details and registration information will become available later this fall. Veterans are also welcome and encouraged to participate with OAS at any point during the season and OAS offers any new-to-OAS athletes their first three lessons at no cost. Lessons commence at Mt Bachelor on December 21st and Hoodoo on January 13th.

Wishing you and your family a Happy Thanksgiving and a very Merry Christmas.



MS Liaison Report





Dan Service - MS Liason

Hello my fellow members. I have volunteered to be the Multiple Sclerosis (MS) Liaison for our Chapter. I am working along with Harriet Schmidt, also a fellow member, who has graciously volunteered, like I have, to see what we can find that will be of benefit to those of us with MS.

First off, we would like to share some exciting news from our PVA National Office: "Paralyzed Veterans of America – the nation's premier non-profit of choice for disabled veterans, their families, and caregivers – is expanding its membership as medical technology advances early detection of MS, inviting all veterans with MS to join." That's right, all veterans with MS may now join PVA.

The article goes on to encourage people to join by saying: "Among the benefits now available are: access to educational materials specific to MS; support from on-staff licensed architects who can review plans and provide subject matter expertise for making their homes more accessible; admission to PVA's private, membersonly Facebook Groups that keep members abreast of important news that impact them; engagement with over 33 Chapters across the country that support advocacy efforts specific to the MS community; and opportunities to take

part in important surveys and webinars, as well as participate in sports and recreation events both virtually and in-person around the country."



2022 National Trapshoot

This year our Tri-State Chapter was involved in participating with our National PVA, by hosting PVA's 2022 National Trap shoot which was held on 23-25 September. There are other National events put on year round that help us be as active as possible want.

Our Chapter shares a Recreational Fund to our members that is the best in the nation (that we know of). We provide many opportunities for our members to volunteer at, or participate in different events, whether something of our own, or other events we attend.



Harriet has indicated that there may be members of our Chapter who are ambulatory, and not paralyzed, that might not feel, as she did, that they "aren't exactly the target market for the aim of the organization." She then asked: "I guess I would like to know why the PVA is interested in MS folks . . . ?" My understanding is that lesions may eventually be on the spine of people with MS in some way, so people, like myself and Harriet, who have lesions on our spinal cords, have our problems of walking. I was not aware, but Harriet told me spinal lesions can cause numbness, paresthesia (strange and uncomfortable sensations), foot drop, gait (walking) problems, bowel and bladder difficulties. Harriet is here, she can find out for us what we need to know, and the pros/cons. and the dos/don'ts of different situations.

Harriet is a perfect example of most of our MS members. She stated: "I know I have been a

member for many years now but never participated until coming to the dinner on Saturday. Never used the Recreation Fund, never showed up to anything, just read Paralog only."

The dinner she is referring to is our Membership Banquet that was held in Wilsonville on September 17th. We had a good turn out, but it would have been better had more members been there. It's free, so come next year (use your \$250 Recreational Fund for gas, hotel, or food on the way).

I feel, overall, that the expansion of the membership for all veterans with MS is wonderful, and that our present membership has an opportunity to expand our overall membership, by letting other veteran's with MS know of the great program they can be a part of belonging to PVA National, and especially our Tri-State Chapter.

Oregon Department of Veterans' Affairs to Host Statewide Veterans Day Ceremony at Oregon State Capitol Park.

SALEM, Ore. - The Oregon Department of Veterans' Affairs will honor all veterans of the U.S. Armed Forces during its Statewide Veterans Day Ceremony this year in view of the Oregon State Capitol Building.

The event will feature remarks by federal, state and local dignitaries and ceremonial elements including color guard, national anthem, wreath presentation and the playing of "Taps." Attendees should be advised that this year's event will be held at 11 a.m., Thursday, Nov. 10 — the day before Veterans Day.



The event will be hosted at the Oregon State Capitol Park located on Court Street Northeast in downtown Salem — directly in front of the Oregon State Capitol Building.

While the celebration will honor Oregon veterans of all eras, there will be special recognition of Oregon's Korean War generation. ODVA is honored to welcome Consul General Eunji Seo of the Consulate of the Republic of Korea in Seattle, Wash., who will serve as one of the event's keynote speakers.


Tri-State PVA,



Government Relations

Here comes our Glorious Fall. The leaves are starting to turn that beautiful vibrant orange color and political campaigns are kicking into high gear. By the time you read this, we will be in the cool-down period we get every year before the cold wet air starts to permeate in. Speaking of permeating, let's have a look at what our Federal and State Governments have been up to lately. It looks like the politicians in DC did some good old fashioned can kicking as they passed a CR (Continuing Resolution) to keep the lights on until Dec 16. Inside the CR were some military operation and veteran benefits that needed funding, so we are grateful for their continued effort, however we would sleep much easier if they would pass an annual budget and stop these "stop-gap funding measures."

The PACT (Promise to Address Comprehensive Toxics) Act has now been passed and we are imploring each member to have our National Service Officers (NSO's) check your benefits to see if additional ones are now available to you. You have

earned them with your service to our great country, so give Matt Paige (NSO) or Margaret Leach in the Portland office a call to have them look and see if you are eligible for new benefits under the PACT act. If you need help with numbers or email, give the Salem office a call (503) 362-7998 and get the info you need to move forward with our NSO. Even if you are not service-connected, there may be new benefits available to you, it does not hurt to ask.



On the accessibility front, Senate Commerce Committee on Science – nominated David Capozzi to be on the BOD of Amtrak. This is a big deal because in the most recent bipartisan infrastructure bill, there was language requiring a person with a disability to be on the board of directors. Capozzi used to work for PVA as Advocacy Director and served on the Access Board. He is a wheelchair user expert who will bring great perspective and leadership in helping Amtrak come into compliance.



Congress is also working on the HISA Act, the auto grant allowance, as well as the Air Carriers Act which PVA has been an essential part of drumming up support for. Congress is also working on the Major Richard Star Act Senate Bill 344, this vital piece of legislation once passed, will allow service-connected combat vets access to their retirement pay as well as their veteran's compensation if they served less than 20 years. Make sure to call your Senator and tell them you support this act, along with the other vital legislation mentioned above.

On Nov 10, in front of the State Capitol at Capitol Park there will be a Statewide Vets Celebration, this year we are honoring all Korean War Vets. On Nov 11, in Albany, we will have a float for the parade this year, so call the office to get on board, wave your flag, say hello to the crowd, and have a good time. This Patriotic event is now the largest Veteran's Day Parade West of the Mississippi, so don't miss out this year.

ODVA has announced the 2023 Women's Veterans Conference May 21-23, 2023, at the Salem Convention Center. Dave Holtz, a White City, Oregon native, is now the Portland VA Hospital Director. He is excited to be taking over the helm up on the hill. He's an energetic people person, so expect to see him walking around and talking with vets in the future.

Over in Idaho, the new 49-million-dollar Post Falls Veterans Home is now accepting applications for residency. This 83,400 sq ft facility is located on 7.3 donated acres in the Riverbend Commerce Park. It will have 64 private rooms, with a common community center housing a dining room, common spaces, and administrative offices. It joins Lewiston, Pocatello and Boise as Idaho's 4th Veterans Home. It will be owned by the state of Idaho and operated by the IDVS, while the U.S. Department of Veterans Affairs exercises some joint oversight with the IDVS through joint inspections, audits, and record keeping. The goal behind the effort to build the state's fourth veterans' home is to enhance veterans' quality of life by providing a safe, homelike environment.

Washington State Department of Veteran Affairs has received a grant from the Federal VA to help combat veteran suicides in rural communities. Studies have shown connecting benefits to veterans as quick as possible helps prevent suicide. The SSG Fox grant will allow WDVA to extend current suicide prevention efforts with additional Veteran Community Outreach Coordinators located in targeted rural communities. Coordinators will be local staff skilled in Veteran benefits and healthcare enrollment, as well as early suicide-risk identification and intervention screening. This effort is part of the new #988 National Suicide Prevention hotline established by Congress in 2020. Annual veteran suicides had been on the rise staying steady over 6300 per year since 2008, topping out at 6491 in 2019. A light is beginning to shine at the end of a very dark tunnel, there were 6146 veteran suicide deaths in 2020, which was 345 deaths lower than 2019. Mental health plays a huge part in veteran suicide and having the new 988 hotline is showing progress. Connecting veteran's benefits to our service members as quick as we can, is vital to insuring suicide deaths stay on the decrease.

It's nice to know our leaders and community advocates are working hard to make sure every benefit our veteran's have earned are available to them. Government Relations is all about our bringing them to your attention, your job is to call your legislator and advocate for these and other veteran bills. As a veteran, we are never retired, we must keep our eyes and ears open, help those who need it and advocate on behalf of all citizens. Even though we may not wear the uniform, our service to our nation does not end, until we take our last breath and are called home. May God Bless You and...

2023 COLA ANNOUNCED FOR VETERANS AND SOCIAL SECURITY BENEFITS

The Social Security Administration (SSA) announced on October 13 that Social Security benefits will receive an 8.7 percent cost-of-living adjustment (COLA) increase starting in 2023. The increase is reflective of the effects of inflation. On October 10, the President signed legislation ensuring that certain veterans' disability compensation programs will receive the same COLA. Military and federal employment retirement benefits will also be increased.

RATES FOR VA HOUSING ADAPTATION GRANT PROGRAMS RAISED

The value for some of VA's housing adaptation grant programs were raised at the start of the new fiscal year which began on October 1, 2022. The maximum rate for the Specially Adapted Housing (SAH) grant is now \$109,986 and the Special Housing Adaptation (SHA) grant is now \$22,036. Additionally, rates for the Temporary Residence Adaptation (TRA) grant were raised to \$44,299 for the temporary version of the SAH grant and \$7,910 for the temporary SHA grant. The TRA grant assists veterans who qualify for an SAH or SHA grant but are living temporarily in a family member's home that needs modifications to improve accessibility.

UPDATING VA'S HOME MODIFICATION GRANT PROGRAMS

The rates for VA's Home Improvements and Structural Alterations (HISA) grants do not increase to reflect the increased costs of construction. Currently, veterans who need a housing modification due to a serviceconnected disability may receive up to \$6,800. Veterans who rate 50 percent service-connected may receive the same amount even if a modification is needed due to a non-serviceconnected disability. Veterans who are not service-connected but are enrolled in the VA health care system can receive up to \$2,000. These are the maximum amounts an eligible veteran can receive in their lifetime.

In the past 12 years, most of VA's home modification grant programs received annual increases that cumulatively raised their value by 50 percent. So, if Congress had indexed the HISA grant program to the same inflation index the other programs use, or, if lawmakers regularly approved increases to keep up with inflation, HISA grant rates would be one and a half times higher than they are now.

Congress can restore much of the HISA grant program's purchasing power by passing the Autonomy for Disabled Veterans Act (H.R. 5819/S. 4721). This legislation establishes new base amounts of \$10,000 for veterans with a service-connected disability and \$5,000 for veterans with a non-service-connected disability. It also requires VA to apply an inflation formula to keep them relevant in future years. Urge your Senators and Representative to take action now by clicking here.

VA EXTENDS DELAY OF NEW EHR DEPLOYMENTS

On October 13, the VA announced it would be delaying upcoming deployments of the Oracle Cerner electronic health record (EHR) until June 2023 to address challenges with the system and make sure it is functioning optimally for veterans and for VA health care personnel. This decision comes after Secretary Denis McDonough announced in July that the VA would delay EHR deployments until January 2023 to ensure that the system's issues had been resolved. Recently, the VA identified several issues needing additional attention at sites where the new EHR system has already been deployed.

Over the next few months, the VA will work closely with Oracle Cerner to resolve issues with the system's performance, maximize usability for VA health care providers, and ensure veterans are served by an effective EHR. In addition to the system review, the VA will be sending letters to every veteran who may have been impacted by these system challenges in some manner, asking that if they have experienced a delay in medications, appointments, referrals, or test results, to contact the VA through the call center or online. Once they reach out, these veterans can expect a member of their care team to follow up with them within five business days to resolve the issue. VA BOWEL AND BLADDER PROGRAM UPDATES

Over the past year, the VA has been making changes to the Bowel and Bladder program. The Office of Community Care, in collaboration with the SCI/D National Program Office, has developed a standard form and two letters related to payments, which are currently pending Office of Management and Budget review and approval. In addition, the two offices are updating processes and communication related to payments. Last year, VA centralized the payment process. These additional changes will further standardize the claims process. PVA is also working to make additional improvements to the program's administration.

PVA FILES COMPLAINT ON INACCESSIBLE GLOBAL ENTRY KIOSKS

After a member's complaint about Global Entry kiosks at Fort Lauderdale-Hollywood International Airport (FLL), PVA filed a complaint with the Department of Homeland Security (DHS), Office for Civil Rights and Civil Liberties (CRCL). Upon arrival at FLL, the member found that the Global Entry kiosks were inaccessible. The kiosk requires facial recognition to take the picture necessary to present to the U.S Customs Agent. However, the cameras at the top of kiosks were too high to capture the member's photo while seated in a wheelchair.

Section 508 of the Rehabilitation Act requires electronic and information technology used by federal agencies be accessible for individuals with disabilities. PVA's formal complaint filed with CRCL alleged that FLL's Global Entry kiosks violate Section 508. CRCL recently acknowledged the complaint and sent it to the DHS Office of Inspector General for review.

FEDERAL STUDENT LOAN FORGIVENESS APPLICATION IS LIVE

The Department of Education recently launched the Federal Student Loan Forgiveness application. This one-time debt relief is offered to any student that has a federal student loan. Collective student loan debt in the United States is an estimated \$1.75 trillion and the government is offering financial relief to eligible borrowers.

Eligibility criteria depends on your tax status in the years of 2020 and 2021. Borrowers who earned less than \$125,000 in 2020 and 2021, and who did not receive Pell Grants, may be eligible for up to \$10,000 in forgiveness. For families, the threshold for earnings is \$250,000 during those same years.

Borrowers who were the recipients of Pell Grants with those income thresholds, may be eligible for up to \$20,000 of forgiveness.

The application is quick to complete and can be found here. The deadline to apply is December 1, 2023. If borrowers are unsure about the status of their loans, they can go to Studentaid. gov to review their loans and their status. The Department of Education will determine eligibility and will contact applicants if additional information is needed. Borrowers will be notified by their loan provider when their application has been processed.

PHILADELPHIA AGREES TO IMPROVE SIDEWALKS AND CURB RAMPS

Recently, Philadelphia agreed to a fifteen-year settlement to construct and fix curb ramps in the city. The settlement agreement, which is awaiting court approval, resulted from a lawsuit filed in 2019, Liberty Resources, Inc., et al. v. City of Philadelphia. The four plaintiffs in the case use mobility devices due to their disabilities. The plaintiffs alleged that the city's curb ramps and other walkways had physical barriers that impacted their ability to freely travel around the city; curb ramps were broken, steep, crumbling, and had inadequate detectable warnings; and the barriers made traveling independently difficult or impossible. The plaintiffs had experienced injuries from falling out of their wheelchairs or tripping over the obstacles. The plaintiffs sued the city alleging violations of Section 504 of the Rehabilitation Act and Title II of the Americans with Disabilities Act.

Over the next fifteen years, the city must take steps to repair existing curb ramps, install new accessible curb ramps, and maintain accessible curb ramps. Under the agreement, whenever the city constructs a new road or street with a pedestrian walkway, it must install accessible curb ramps, when feasible. The city agreed to install or repair at least 10,000 curb ramps within fifteen years, with a timeline of at least

2,000 every three years. By the end of the third year, and moving forward, the city must allow residents to submit requests for installation, repair, or maintenance using the city's website, phone app, by telephone, or in-person. The city must also make the number and location of the curb ramps publicly available.

WEBSITES AND SOFTWARE APPLICATIONS ACCESSIBILITY BILL INTRODUCED

Senator Tammy Duckworth (D-IL) and Representative John Sarbanes (D-MD) recently introduced legislation to decrease accessibility barriers in websites and software applications. The Websites and Software Applications Accessibility Act (S. 4998/H.R. 9021) would require the U.S. Department of Justice (DOJ) and U.S. Equal Employment Opportunity Commission to establish clear and enforceable accessibility guidelines for websites and software applications. The legislation seeks to address and remedy the systematic problems that exclude individuals with disabilities from equal participation in and equal access to all aspects of society. In March 2022, DOJ issued guidance on website accessibility under the Americans with Disabilities Act (ADA). However, clear standards have not yet been promulgated. The legislation recognizes that without equal access to websites and applications, many individuals with disabilities are treated as second-class citizens. Due to differing opinions by the courts, the bill seeks to reaffirm that the ADA requires websites and software applications be readily accessible and useable by individuals with disabilities.

CSP Broadens Services to Caregivers

VA's Caregiver Support Program (CSP) is enhancing services offered to caregivers of

veterans. One of them, Caregiver Health and Wellbeing Coaching, empowers caregivers by helping them focus on their own health and wellbeing. It pairs caregivers with trained coaches (staff members from local CSP teams) who offer guidance in developing personalized health plans based on the caregiver's values and needs. Also, it connects caregivers with the resources that will help them achieve their goals. Coaching services are not offered at all locations so caregivers will need to contact their local CSP to check availability. Click here to view the full announcement.

The Administration for Community Living (ACL) released its first comprehensive report on the accomplishments of Older Americans Act (OAA) Title III, VI, and VII programs. Enacted in 1965, the OAA supports an extensive system of services and supports for older adults, targeting those with the greatest economic or social need, particularly low-income and minority persons, older individuals with limited English proficiency, and older persons living in rural areas. The report provides an overview of the history of the OAA; the purpose and services of the Title III, VI, and VII programs; and summarizes accomplishments and results for each of the programs using 2020 data. National Strategy to Support Family Caregivers Now Available for Comments

The National Strategy to Support Family Caregivers released on September 21 is now open for a 60-day public comment period. Comments are due by the end of November. To submit comments, interested parties are asked to use the online form on the Administration for Community Living's website: Instructions for commenting are included at the link. Comments may be directed to the strategy globally or on any of its four components.

Fraud Alert for PACT Act Scams

The VA wants veterans to know that there has been an increase in PACT Act-related phishing

(email), vishing (phone), and social media scams targeting veterans to access their PACT Act benefits or submit claims on their behalf. Veterans should always be cautious of anyone who guarantees a lucrative financial benefit or service and remember that PVA service officers will assist you with your claim for free. Justice Department Resolves Disability Discrimination Lawsuit Against Housing Authority of New Orleans Properties

On October 3, the Department of Justice announced that the Housing Authority of New Orleans and seven private developers have agreed to pay \$250,000 to settle claims that they violated the Fair Housing Act and the Americans with Disabilities Act by failing to design and construct eight multifamily residential properties and associated places of public accommodation in accordance with those laws. As part of the settlement, the defendants also agreed to make extensive retrofits to remove accessibility barriers at the properties. The properties at issue are Bienville Basin, Columbia Parc, Faubourg Lafitte, Fischer Senior Village, Guste III, Harmony Oaks, Marrero Commons, and River Garden.

Assistance Available for Veterans After a Natural Disaster

The VA recently published resources available for veterans, dependents, survivors, and caregivers who have experienced a natural disaster. A SitRep YouTube video outlines what assistance is available and where to go for help.

Also, the VA is offering a suspension of debt repayments for veterans and family members affected by Hurricane Fiona or Hurricane Ian. For suspension of benefit debt, veterans and beneficiaries can contact the VA Debt Management Center via Ask VA (select Veterans Affairs-Debt as the category) or call 800-827-0648. For suspension of medical care and pharmacy copayment debt, veterans and beneficiaries can call 866-400-1238. Veterans can also check the status of their VA debt online on VA's debt portal.

HUD Awards Funds to Modify and Repair Low-Income Veterans' Homes

The Department of Housing and Urban Development (HUD) recently announced that \$5 million is now available to modify and repair low-income veterans' homes. The funding is expected to support 330 low-income disabled veterans. Details can be found here.

Disability Statistics Compendium Released

The annual state of science conference on disability statistics took place on October 6 and 7 and focused on the release of the 2021 Disability Statistics Compendium. The conference is hosted by the University of New Hampshire, Rehabilitation Research and Training Center on Disability Statistics and Demographics. A chapter of the report devoted to veterans provides data on veterans with a serviceconnected disability rating; the prevalence of disabilities in the veteran population; the portion of the veteran population that experiences poverty [as well as the difference between the poverty rates of veterans with and without disabilities (poverty gap)], by disability status. Reeve Foundation Summit

The Christopher and Dana Reeve Foundation held its third annual summit in Washington, DC on October 13 and 14. Bringing together advocates, family members, researchers, and other stakeholders, the conference featured presentations on the challenges faced by caregivers, updates from the Administration for Community Living, planning for pregnancy with SCI, and the latest in research on SCI/D. PVA Associate Executive Director for Government Relations Heather Ansley appeared on a panel discussing air travel issues and the legislative and policy environment for addressing them. VA Requests Feedback on Motto

As the number of women veterans increases, the VA is seeking ways to make its facilities more inviting to them. Many women report feeling unwelcome at VA medical centers which often serves as a barrier to them receiving care.

Some women veterans feel that updating the VA motto would help them feel more welcome. The current VA motto, "To care for him who shall have borne the battle and for his widow, and his orphan," Is an excerpt from President Abraham Lincoln's second inaugural address in March of 1865.

In recent years, the VA and veterans have debated if there is a way to make the motto more inclusive for women veterans. To understand the perspective of veterans across the country, the VA is conducting a survey to assess what veterans think might be the best way to adapt the motto to include the service and sacrifice of women, who are currently the fastest-growing demographic in the veteran population.

PVA VETERANS CAREER PROGRAM UPDATE

Understanding Your Employment Options



Fay Smith is an Army Veteran with 100% disability, and a PVA Member. She initially reached out to the Veterans Career Program (VCP) at the start of the COVID-19 pandemic. Our Vocational Rehabilitation Counselor, Genia Hachenberg, maintained contact with Fay over the next year as she

contemplated re-entering the work force; but Fay repeatedly felt overwhelmed by physical, mental and emotional strain. In October 2021, Fay reached back out to VCP after attending the PVA Women Veterans Empowerment Retreat in Tempe, AZ (where Genia had given a Zoom presentation on employment).

Fay indicated that she wanted training to update her work skills, and to pursue part-time work. She also indicated she had serious concerns about her SSDI benefits and the risk of losing them. They discussed work incentives such as Ticket to Work (TTW), and agreed to look at the impact of any earned income before pursuing employment opportunities. Fay began taking Saylor Academy courses and volunteering at Longleaf Hospice; and expressed plans to pursue part-time work from home in the New Year.

They revised her resume, explored local part-time opportunities and continued to discuss the TTW program. By mid-2022, Fay decided to pursue a caregiver position that was comparable to her volunteer work and allowed for a flexible, part-time schedule. She has been working since June, and they have tracked her earnings very carefully so she feels confident working and retaining needed benefits.

Fay attended WVER again this year in San Antonio, TX, and shared with other attendees how VCP has positively impacted her life. "I don't want to live in fear. I don't want to be paralyzed by fear. I felt useless, discarded and betrayed by my body. Volunteering and working have helped me redefine my goals and helped me get in a more disciplined mode. It's creating a routine and balance in my life."
