

The Peer Mentoring Program will match newly injured or diagnosed SCI inpatients with trained peer mentors that have made a successful adjustment to SCI or disease as they have asked the same questions and faced similar challenges.

## **SPORTS**



## **GOVERNMENT RELATIONS**

Was 2021 a reemergence of the 2020 fever of discontent? Like many veterans continuity of access to VA services while dovetailed into the Covid-19 pandemic made for concern across the veteran landscape. Fear not, your VA and PVA/OPVA remain at the helm working for you.

VA funding remains firmly in place with anticipated increases in program services such as women's critical health care, access to Care Giver assistance, athletics.

OPVA working with UVGO achieved a significant goal: group fishing license for a single fee.

Oregon legislators fielded roughly 19 other pieces of veteran legislation from housing to community grants to homeless intervention. Handicap Parking advocacy won first prize for Group Gripe.

On a sad note we lost veteran advocate Jim Willis, the torch bearer for all things veteran. As of this report massive funding legislation is stalled in Congress. Most assuredly VA services remain strong and responsive. Along the Oregon Trail OPVA is there for you.

## **FUNDRAISING**



The Oregon Chapter continues to set goals to help our members in every way possible. We do this with fundraising events such as our Gold Cup Golf Tournament at McNary Golf Club in Keizer and our Show & Shine Car Show in South Salem. We also held our annual raffles a Can-AM ATV raffle and a \$500 Outdoor Adventure Package for a Sportsman's Warehouse gift card.
