

COMMUNICATION





PVA Tri-State's Paralog Magazine is sent out to all our members and others involved directly with the Chapter. This is a bimonthly magazine that includes all our upcoming events, update reports from our Board of Directors, articles from members and sponsors, etc. We do have a part time Graphic Designer whose main focus is designing and production of our Paralog; as well as all the different flyers that are produced. We use electronic

billboards to bring awareness to events and fundraisers; as well as our website, and social media for updates and information; along with mailing out flyers to our members; making lots of phone calls and whatever we can to get through to our members and everyone concerned. We also attend many different Fairs and Festivals for the Chapter to inform the public of our purpose and mission to improve the outlook for our Veterans.

PEER MENTORING

This year PVA Tri-State has made progress developing a Peer Mentor Program. The primary purpose is to help veterans with Spinal Cord Injury and/or Disease (SCI/D) and their families: adjust to the onset of new impairments and disabilities; better understand the rehabilitation process; develop new social skills and relationships to transition to community living. Peer Mentors serve as role models by sharing experiences and practical suggestions regarding living with SCI/D, listening to the concerns of the individual and responding

in such a way as to facilitate the rehabilitation process and enhance the quality of life.

Peer mentoring has proven to be a key factor in adjusting to life with SCI/D. Based on the philosophy that the person who can be most effective in providing support is the one who has shared similar experiences, and peer mentoring offers the veteran insight and practical suggestions in dealing with a variety of issues that arise after SCI/D.

SPORTS



The 2022 PVA Tri-State sports programs have had some ups and downs thru out the year. The trapshooting since the COVID pandemic has slowed way down and is not back up where it was. However, we still have a trap team and we are looking forward to a better year in 2023. PVA Tri-State hosted a National Trapshoot in September, on the 23rd thru the 25th, at the Hillsboro Trap and Skeet Club. It was very successful and lots of fun.

We also have a very successful Air Gun program that shoots every other month at an indoor range provided by the Albany Rifle and Pistol Club at no charge for the Chapter.

On July 16th, PVA Tri-State hosted our annual Gold Cup Golf tournament in Keizer OR, at McNary Golf Club.

This is one of our biggest fund-raising events that we do every year with the turnout growing to and unbelievable number of golfers and volunteers.

Our next biggest sports event is our Deep Sea Fishing trips we offer to our members and assistants. We work with Dockside Charters out of Depoe Bay, OR to schedule three bottom fish trips and one salmon trip each year, this program has been very successful and fun for our members with lots of fish and crabs caught each trip.

MEMBERSHIP



Membership for PVA Tri-State is constantly evolving; our organization is currently comprised of a total of 281 members, 134 SC (service connected) and 147 NSC (non-service-connected). We started 2022 with 290 members of which 148 are service-connected and 142 are non-service-connected We currently have 61 having Cervical injuries, 18 lumbar injuries and 59 with thoracic injuries. The others are spinal cord disease with 92 MS, 19 ALS and 32 Other.

Service to our country comes with a sacrifice, and many of our members were in our nation's wars and conflicts. For period of service, we currently have: 6 Korean War conflict; along with 138 Vietnam War; 64 Gulf War; and 135 Peacetime members.

GOVERNMENT RELATIONS



Pushing Access Forward, is our new mantra, and 2022 was a year of action for our Chapter. On the Government Relations front, we are establishing longterm relationships with Federal, State, and County leadership across our vast jurisdiction. At the National level the PACT (Honoring our Promise to Address Comprehensive Toxics) Act was passed and signed into law. This legislation expands VA health care to more than 3.5 million Veterans exposed to toxins and could potentially benefit 1 in 5 current Veterans. It represents the largest Veterans' health care bill in decades. The legislation is a win-win for all vets, because it opens the budget to hire more VA staff who will implement it and verify every veteran has the care and support, they have earned with their "service and sacrifice." Our Legislators should be applauded for once again putting vets first. Many of our members will benefit from this vital piece of legislation that will reform the VA well into this century.

The "Raise Act" was passed and signed into law this year it addresses the needs of our nurses and doctors within the VA, making sure they are receiving the benefits and pay they are entitled to.

The "Veterans Auto and Education Improvement Act" has been passed and is now signed into law. This legislation allows a qualified veteran who received an auto grant 30 years or more ago, to receive a new auto grant from the VA. We will work with our leaders to ensure this new legislation is implemented and our members will have access to funds to purchase a new vehicle.

Our women veterans will benefit from the MAMMO Act (Making Advances in Mammography and Medical Options for Veterans Act) It established a new standard within the VA for all nursing mothers to have private nursing units to nurse their babies while at the VA. Many other options in women's medical care are also included.

On the local level we are working with and lobbying our leaders to address veteran homelessness and hunger. Our states have the desire to fix this problem, we must work together to help them do it.

In Oregon, your Chapter is a member of UVGO (United Veterans Governmental Organizations) where we advocate for and join forces to lobby our leaders to address veteran issues and needs.

In SW Washington, we are a member of the CMAC (Community Military Appreciation Committee) where we work with local leaders advocating for military and veteran issues within the community.

In Idaho we are working with our Idaho Ambassador to establish relationships with local and state leaders to lobby and advocate for veterans needs within the state.



FUNDRAISING



PVA Tri-State continues to set goals to help our members in every way possible. We do this with fundraising events such as our Gold Cup Golf Tournament at McNary Golf Club in Keizer and our Show & Shine Car Show in South Salem. We also held our annual raffles an Arctic Cat ATV Raffle which we drew the winner live at the Marion County Fair, as well as a 1977 Corvette where the winner was drawn live at the Oregon State Fair and they were

present at the drawing. We did unveil our next raffle ATV at our annual Gold Cup Golf Tournament, which is a CF Moto CForce 800 XC, this will be displayed at many events throughout the year. Grants and donations are a big part of what's keeping us going, we keep moving forward to enrich our veterans' lives. In 2023, the Chapter plans on hiring a Development Coordinator to assist in Fundraising activities.













CHAPTER ADMINISTRATION

Paralyzed Veterans of America Tri-State Chapter currently has a very secure and trustworthy office staff. Our Office Manager and Executive Director work hard to follow the bylaws of operation for the Chapter.
